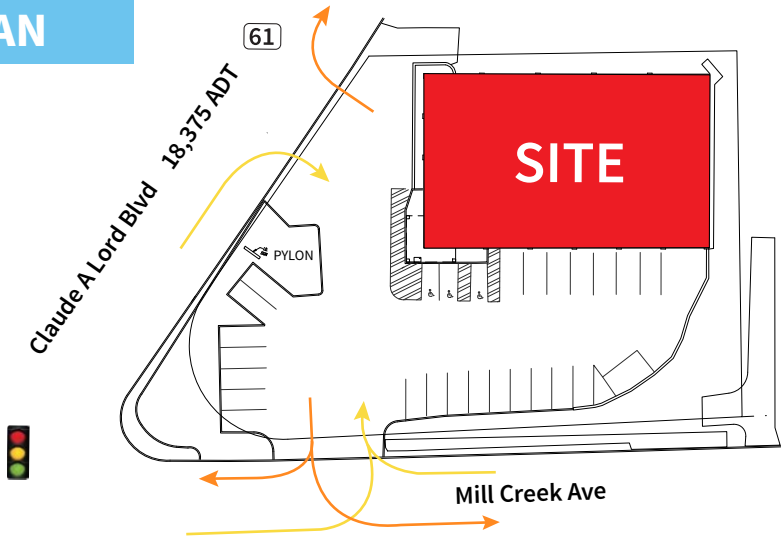

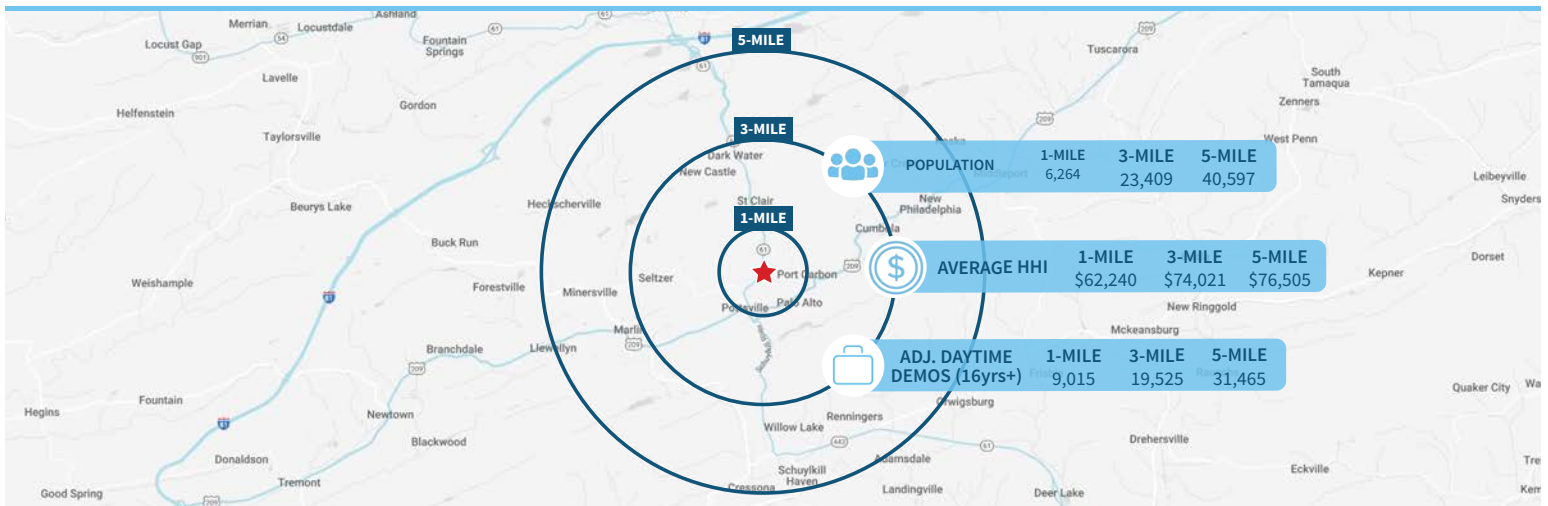

**Demographic Overview (1, 3, 5-mile radius)**

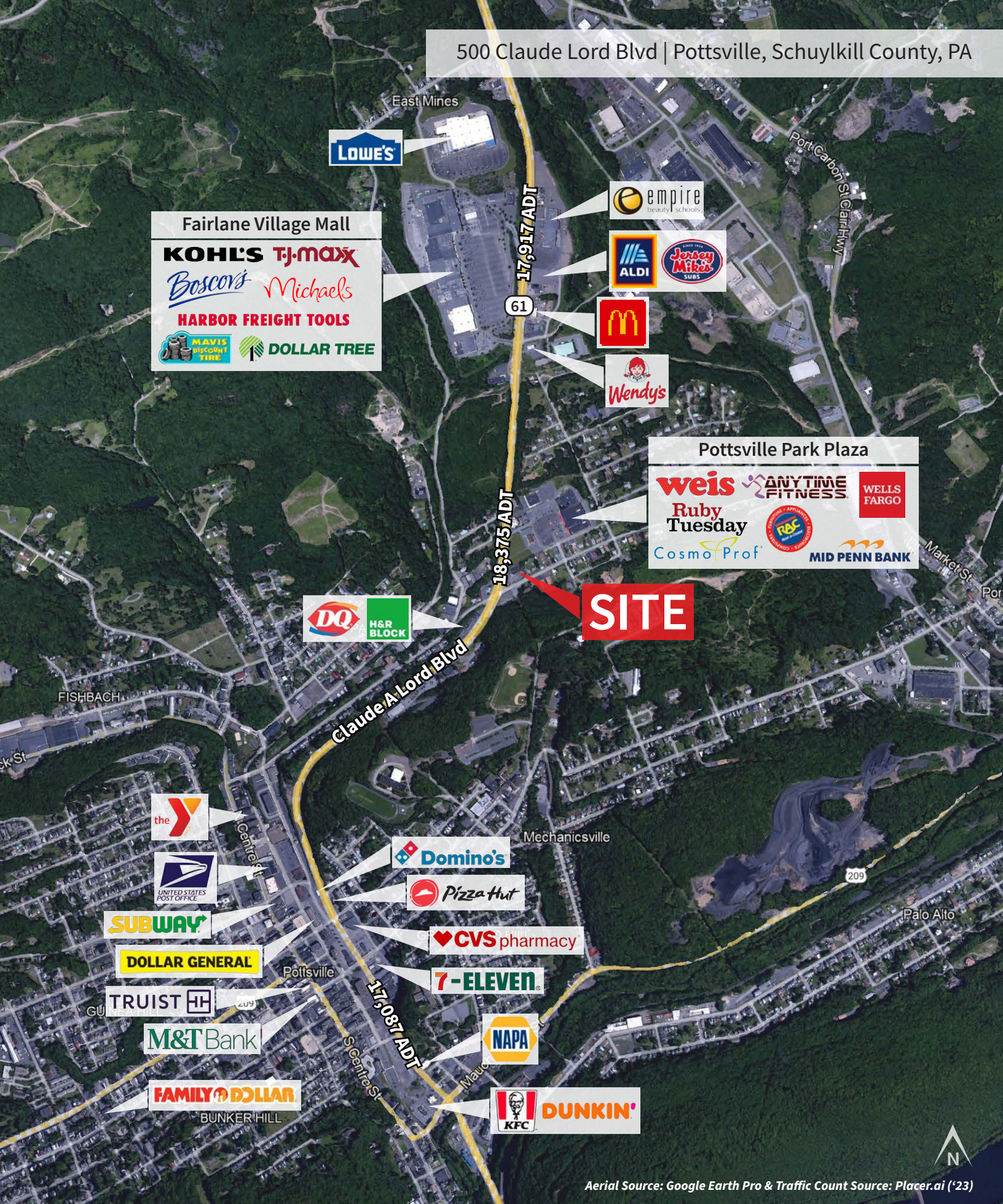
